



ASTA Point/Time Sheep and Duck Trial in Branchville, NJ. Sunday, November 30, 2008

Hosted by: OUTBACK FARM (www.outbackfarm.net)

Handler's meeting at 8:am. Runs start at 8:30am.

3-5 head of stock per run, depending on number of entries. Open to all herding and mixed herding breeds.

Limited number of entries, pre-entries close November 15th there will be no refund after that date. Day of Trial entries are cash only and will be accepted if the entry limit has not been reached. Cash payouts will be awarded for all divisions. Payouts will be scaled to division. All money collected from entry fees goes to payouts after trial expenses are deducted.

There are no judges in point/time trials. The dog/handler team that earns the most points by working stock through the course obstacles wins the class. Each head of stock going through the obstacle is awarded points. If there is a tie in the number of points earned, then the fastest time determines the winner. In all classes, at least one head of stock must successfully negotiate an obstacle in the announced order to earn the right to continue on to the next obstacle. Novice handlers may go anywhere on the course except through obstacles. Intermediate and Advanced will have handler restrictions. FMI: <http://www.a-s-t-a.org>

Trial will start with the Advanced class, followed by Intermediate, and then Novice.

Handlers may only carry a crook or stock stick, and will not be allowed to touch either the dog or the stock. Dog and handler will be disqualified for any abusive conduct towards animals or people. Excessive running of livestock or gripping will be cause for disqualification. Outback Farm reserves the right to reject, expel and/or refuse entries for any reason whatsoever.

From the PA & NY state: Take Route 84 to Milford, PA (Rt. 6 & Rt. 209 S). Follow thru Milford, turn left onto Route 206 S & go over the Delaware River into NJ. Follow Rt. 206 S for approximately 20 minutes. Pass Dairy Queen on right, Luk Oil gas station on left, turn right onto UNION TURNPIKE (rt. 630 W). Take the first LEFT onto STEMPERT RD. & farm is #18 on the left. Split rail fencing around property. (please note that Union Tpke. & Rt. 630 come out in a couple of places on rt. 206).

From the South: Take Rt. 287 N, to Rt. 80 W, to Rt. 15 N, follow straight onto Rt. 206 N. At the intersection of Rt. 15 & Rt. 206 ******(Ross's Corner - Exxon, Chatterbox drive in food), go through 4 more traffic lights (approx. 4 miles), pass Legion hall, Kents liquor store, & take the second LEFT onto UNION TURNPIKE, (rt. 630 W). Take the first LEFT onto STEMPERT RD. & farm is #18 on the left. Split rail fencing around property. (please note that Union Tpke. & Rt. 630 come out in a couple of places on rt. 206).

From the West: Take Rt. 80 E to Rt. 94 N. Follow 94 N. to Rt. 206 N (Newton). Follow Rt. 206 N. to Ross's Corner, turn left at Ross's corner & ******follow directions from the south.

From North Eastern NJ: Take Rt. 287 S. to Rt. 23 N, to Rt. 517 S (towards Sparta). Take Rt. 15 N. to Rt. 206 N. & ******follow directions from the south.

From New York City: Take Rt. 80 W, to Rt. 15 N, to Rt. 206 N, & ******follow directions from the south.

AGREEMENT

As a participant in the ASTA Stockdog Trial, I agree that in the event of personal injury, damage to property or animals I hereby release ASTA, it's members, the trial committee, the property owner or agents and hold it harmless from all present and future loss, injury, damage, claims and liabilities involving the entered dog, the event or the event premises. I also understand that any questions, concerning trialing or rules will be ruled upon/decided by the trial committee and this decision will be final. However, any problems or conflicts should be brought immediately to the attention of the trial committee.

Exhibitor/Owner will abide by the rules of the event and the decisions of the trial committee. Exhibitor/Owner certifies that entered dog is not a hazard to persons, dogs or other animals or property.

The person, owner, exhibitor signing this agreement certifies that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of the entered dog. In the event that an entered dog injures stock, the owner agrees to pay all veterinary fees associated with the general well being of that animal. If the injury is severe or fatal, the owner will pay the market value of the stock.
